

Privacy Policy

1.1 CPI/OTC Exchange Community is strongly committed to protecting the privacy of users of its interactive products and services.

1.2 This privacy policy applies to the otcexchange.info. site and all of the Internet accessible CPI/OTC Exchange Community branded services, which we may offer from time to time, referred hereinafter as CPI/OTC Exchange Community. 1.6 Our site's registration forms require contact information (like name and email address) and demographic information (like zip code, age, and income level). We will not disclose your personal information to any third party advertisers unless we are compelled by law or, in our sole discretion, whenever we believe an emergency, illegal activity or some other reasonable basis exists for notifying or providing such information to the appropriate authorities. We reserve the right, directly or through our designated marketing agents, to distribute promotional materials to you for CPI/OTC Exchange Community products or for products of our marketing partners.
